- One time Registration Fee of \$20.00.
- Each week the Junior Greens Fee of \$13.00 must be paid.
- Fee includes hot dog and fountain drink, green fee and instruction.
- Prizes awarded on championship day.
- Limited to first (24) paid participants in each class.

Each child must have his/her own equipment. Golf shoes are recommended but not required. Any shoes that may cause damage to greens (i.e. baseball/soccer cleats and lug soles) are not permitted. Proper golf attire must be worn at golf course. T-shirts are acceptable but sleeves are required on boy's shirts. In championship and scramble format, players will be assigned to foursomes and parent volunteers are needed to help score. In other weeks, parents are welcome to walk and observe or help supervise play.
